

In this role, she serves as an advisor and technical consultant to states, counties, tribes, and regions across the country in issues related to substance abuse, child welfare, and the courts, providing and coordinating various levels of technical assistance for multiple projects. She has dedicated herself to women with substance abuse issues for over 25 years. Originally from California, she moved to Oregon for college, receiving a B.S. degree from the University of Oregon in Sociology, with an area of concentration in Substance Abuse and Prevention. She spent 11 years in Eugene at the Relief Nursery's Accessing Success Recovery Support Program. Initially a Peer Support Specialist, she advanced to Alcohol & Drug Counselor, eventually managing the Recovery Support Program for six years. Her focus was serving parents with substance use disorders involved in child welfare. In 2006, she spent seven years as a caseworker within Child Welfare. In 2013, she accepted the position as the Women's Treatment Services Coordinator and the Access to Recovery Project Director with the Oregon Health Authority, and Oregon's (NASADAD) Women's Service Network Coordinator.
